Re: Award of Class "A" Pumper

Dear Honorable Body:

On Monday April 27, 2015, six (6) bids were received for a new Class "A" Fire Pumper and are as follows:

1. Pierce Manufacturing (new build)	\$376,130.00
2. Pierce Manufacturing (Alternate #1)	\$361,545.00
3. Pierce Manufacturing (Alternate #2)	\$341,740.00
4. Sutphen Corporation	\$385,214.00
5. E-One	\$367,841.00
6. Empire Apparatus (Rosenbauer)	\$374,566.00

After diligent scrutiny of each proposal, including available discounts, build time, compartment space general layout, and adherence to our specifications, only three (3) bids could be considered. Numbers 1, 4, and 5 were within parameters of our specifications, and all were within \$5,000.00 of the other.

Accordingly, I respectfully request that the Common Council concur with the Fire Department findings, and award the Class "A" Pumper to the Sutphen (sut-fin) Corporation, for their original bid of \$385,214.00 and authorize the Mayor to sign all agreements, pending approval of the City Attorney.

This bid provides the best suited vehicle for the Department in transporting and protection of our equipment, along with the capability to carry added equipment due to the additional compartment space provided.

Traffic Safety Minutes:

The May meeting of the North Tonawanda Traffic Safety Committee was called to order at 1900 hours. Roll call showed all members present. The minutes from the previous meeting were read and accepted. The following new requests/concerns were discussed and recommendations made.

1. Member A. DiBernardo recommended placing a no parking sign on one side of Weaver Parkway near Ward Road. Vehicles parking on both sides of Weaver are making it difficult/unsafe to turn in the area. The Committee is unanimously in agreement with this and recommends Member Daigler place the sign in the correct area of Weaver Parkway.
2. Member R. Frank received a request from a resident on Meadow Drive to place deer crossing signs on Meadow Drive in the area of the High School. The Committee does not feel there is a need for the requested signs and does not recommend placing them.

3. Member Daigler received numerous complaints on parking along 18<sup>th</sup> Avenue in the area of Walgreen's, and recommends placing no parking signs along the North side of 18<sup>th</sup> from Payne to the end of Walgreen's property. The Committee is in agreement with this request and recommends placing the requested signs.
4. The Committee received and filed a Notice of Order, study #29.03-62, from the NYS DOT.

## AUDIENCE PARTICIPATION

Ann Finkle 896 Sun Valley Drive – Stated she is disappointed in the paving of Zimmerman Street, says it is very bumpy and it appears to be done but not up to the standards that she has come to expect of repaving. Asked if the City is taking down Ash trees on city property as needed or as a prophylactic (e.g. to prevent disease) and if it is a prophylactic, why are they not asking the citizens to take their own down. Stated it is extremely expensive to have to cut trees down. Stated there has to be a way the City can take the trees down and not have the public take them down themselves at their own cost. Stated it is for the good of the entire City if the City helps their citizens. Stated there are two huge tree stumps on Rumbold Avenue that have not been ground down and they are infested with ants. Said the residents are trying to spray the ants, but to no avail. Asked if the City has given any thought to changing from 4 meetings (e.g. 2 workshops, 2 council) to 2 meetings a month. Because it has always been done that way, does not make it correct.

Rob Orłowski 598 Meadowbrook Drive – He wanted to thank everyone for allowing him to present the fire prevention trailer to the Council last week. Stated it is a small cost compared to the large budget the City has. Stated it is important to fire prevention to have the use of this training device whenever we want it for the schools, senior centers, and residents of the city. Stated public safety should be top priority for the City.

Kathy Kern 1248 Greenbrier Lane – Stated she agreed with Ms. Finkle; Zimmerman Street is like driving on a rollercoaster. Asked if like in the past the Auxiliary Police are going to get rid of the sign blight. Stated we are at that time of year when everyone places their signs on the poles throughout the city and some people do not take them down after their event. Stated it can be a distraction to drivers and she feels the city should issue a permit if they want to hang a sign. Stated she appreciates what the city is doing to help keep the city clean and nice.

Kevin Hodgson 67 Jesella Drive North – Stated he also agrees that the paving on Zimmerman Street was not a good job, also he supports the fire trailer that Rob is backing. Stated he is sure the city can loan it out and it enhances the city image. Stated give me 10 minutes and he could find the money in the budget for the fire prevention trailer.


