• On May 17, 2016, your honorable body granted the Mayor permission to develop a memorial garden and remembrance walk, known as the Children's Memorial Garden, at Brauer Park. Initially, permission was granted for use of the park only and funding for the project was intended to be by donation only. However, the Mayor has received overwhelming support on the project and has also been notified that there is grant funding available to the City to support his project.

If your honorable agrees to adopt the project for 2017, the City must commit to advance the funds, as they relate to the grant award from DASNY State and Municipal Facilities Program ("SAM") Project ID#7475, to complete this project.

Accordingly, please authorize the City Clerk-Treasurer to loan \$50,000 from the General Fund to the Capital Fund to establish the required financial commitment towards the project. Upon completion of the project and subsequent to reimbursement the loan will be returned to the General Fund.
