

Traffic Safety Minutes:

The November 2018 meeting of the North Tonawanda Traffic Safety Committee was called to order at 1900 hours. Roll call showed the following members present: R. Frank, J. Sikora, M. Lemke, A. Vater, M. Anastasi, A. DiBernardo, D. Grinnell. The minutes from the previous meeting were read and accepted, the following new concerns/requests were discussed, and recommendations made.

- 1. Mark Daigler will work on respective signs for the previous months approved items, which include "no parking" signs on Weaver Pkwy, and "yellow caution" signs on Webster Street. Mark Daigler will also be working with Mark Zellner and Dale Marshall to complete the approved one way street for Geneva Street, \$15180
- 2. The clerk's office received a call from John Hahn regarding people parking and blocking the view on the corner of Louisa and Old Falls Blvd, Hahn asked if a sign could be placed there. Member Sikora checked the corner and found that the cars are parking on the terrace. Member Frank called and left a voicemail for Mr. Hahn advising him that if a vehicle is parked on the terrace he can contact the police station and have that vehicle ticketed. A "no parking" would not be appropriate in this situation as citizens are not allowed to park on any terrace in the city without a permit.
- 3. Member Frank received a letter from Alderman Tylec who received a call from a concerned citizen who would like a crosswalk at Spruce Street and Sweeney Street. Frank spoke to Dale Marshall who stated that a crosswalk could be put in but it would have to wait until the spring due to weather. Frank advised Tylec that the project will be revisited in the spring.
- 4. Member Frank received a letter from Alderman Tylec who received a call from a concerned citizen who would like a stop sign at Selkirk Drive and Doebler Drive. The committee believes that that intersection doesn't need a stop sign as there is a short distance between stop signs on Selkirk Drive already. We would like Traffic Officer Cress to monitor the intersection. Member Frank will advise Officer Cress. Member Frank informed Tylec of the decision.

- 5. The committee received a letter from Traffic Officer Cress. Cress thinks that the new stop signs on Division Street are causing a lot of near accidents, and he believes that it is due to the drivers being confused by the stop signs. The committee would like to continue to monitor Division Street and reevaluate it in the future.
- 6. The committee received two letters from Sandra Eaves and Jim Pyrek. Eaves would like a police presence on Meadow Drive during morning school hours. Pyrek would like the length of time for "school zone" hours on Meadow Drive reduced. The committee does not think either complaint is valid at this time. Traffic Officer Cress is on Meadow Drive on a continuous basis and it is reflected in the amount of speeding tickets that are written on Meadow Drive. The committee believes that reducing the school zone would be irresponsible as there are numerous school events happening at the high school/middle school between the times of 4:00 pm and 6:00 pm.
- 7. Member Sikora and Daigler received a letter from Alderman Berube regarding a complaint he received about the intersection of Oliver Street and 15th / 16th Avenues. This complaint has been received in the past and the committee agreed to put up "no parking" signs to help the visibility issues. Member Sikora has been checking the front of Matt's Music and has found that the stores patrons are parking illegally and causing the problem. Sikora has informed the owner of Matt's Music in the past to tell her patrons not to park in the "no parking" zones and that would help the visibility issues. Sikora will continue to monitor the area.
- 8. The committee received a terrace parking permit from Adam Fenske of 364 Tremont Street. The committee believes that the request is valid and that the permit should be approved.
